

HOSPICE: Every Day is a Gift Specialty License Plate Frequently Asked Questions

1. When will the “Hospice Every Day is a Gift” specialty Florida hospice license plate be available to purchase?

The “Hospice Every Day is a Gift” hospice specialty license plate has been a specialty license plate since 2003 and is available in all tax offices across Florida.

2. I don’t live in Sumter County, if I purchase or renew my Hospice specialty license plate through this online method, will my contributions only benefit Sumter County hospice programs?

No. The online purchase or renewal method is brought to you as a simple courtesy by the Sumter County Tax Collectors Office. Your contributions from purchasing or renewing a Hospice specialty license plate through this method will go directly back to the county where your license plate is registered.

3. I have a standard Florida plate and am not scheduled to renew my license tag within the next 3 months. How much will it cost to switch to the Hospice specialty plate?

Approximately \$65.00.

4. I have another Florida specialty plate and am not scheduled to renew my license tag within the next 3 months. How much will it cost to switch to the new Hospice plate?

Approximately \$65.00.

5. I have a “Hospice Every Day is a Gift” specialty license plate and I need to renew my registration within the next 3 months. How much will it cost to renew my specialty license plate?

It will add approximately \$28 in addition to your registration fee.

6. I have a standard Florida license plate and I need to renew my registration within the next 3 months. How much will it cost to switch to the Hospice specialty license plate?

It will add approximately \$28 for the new license plate fee; \$25 for the specialty license plate fee; and \$5 handling fee – so a total of about \$58 in addition to your registration fee.

7. I have a different Florida specialty license plate and I need to renew my registration within the next 3 months. How much will it cost to switch to the Hospice specialty license plate?

It will add approximately \$28 for the new license plate fee; \$25 for the specialty license plate fee; and \$5 handling fee – so a total of about \$58 in addition to your registration fee.

8. I have a Hospice specialty license plate. Can I keep my plate number when I change to the new plate?

Yes, but it will be considered a “customized plate” with an additional \$15/year fee, in addition to the fees listed above.

9. May I make the switch online?

10. What do I need to bring when I change my plate in person at my local tax office?

Please bring your driver’s license, vehicle registration, and payment.

11. Do I need to surrender my current plate when I upgrade?

No, your old license plate does not need to be surrendered.

Please note:

- Personalized license plate replacements and new requests will vary based on the transaction.
- 10-year forced replacements – If you are at the end of the 10-year plate cycle, the license plate will be replaced, but the \$28 new license plate fee will not be charged.
- Registration fees will vary because they are based on the weight of the vehicle.
- All fees are an approximate amount; fee may vary slightly based on where the transaction occurs.
- Mail fee is not included in any of the above fees.
